- 2. Welcoming Kate Donovan, incoming Director of The Bancroft Library & Associate University Librarian for Special Collections (15 min)
 - a. Three priorities
 - i. Sustainability at Bancroft
 - ii. What collecting means at Bancroft
 - ii. Making Bancroft collections widely accessible as possible
 - b. Looking at collaborations around collections with other libraries on campus
 - Collections that represent the full range of human experience is important
 - i. Continuing to build on the diversity of collections at Bancroft
 - Collections that emphasis the African diaspora (Afro-Mexican freedman, Star Riders)
 - d. Making Bancroft collections as widely accessible as possible can be difficult.
 - i. Mellon Grant to make more collections accessible
 - ii. Papers from Dr. Oliver WIlliamson and D. Leon Litwack among other collections are being opened up to the public.
 - e. Patrons using the Bancroft Library

- i. Bancroft was seeing around 5,000 people in the reading room a year and those numbers have been down since the pandemic, but are now starting to go up.
- ii. 145 classes have come to the Bancroft Library in the last year.

 - 1. Students have been hungry to work with physical materials
 - a. Highlight collections and librarians who are doing that work
 - iv. Virginia Asked about status about Indonesian Studies papers given to Bancroft
 - v. Lots of complications with using collections in Bancroft. Bancroft has a lot of relationships with organizations in the Bay Area and is a trusted partner. Making it smoother for students to cross the threshold of coming into Bancroft is something Kate is committed to doing, as it can be a transformative experience for students.
- Professional Development Trip to the Netherlands and Belgium (J. Ott, 25 min)
 Funded by federal Title VI money (administered locally by the Institute of European Studies)
 - a. 2022 LIBER Conference was held in Odense, Denmark (University of Southern Denmark)
 - i. About 400 people attend the conference
 - ii. Pre-Conference on ebooks "The eBook dilemma: copyright, licencing and digital lending in libraries"
 - Access via libraries for Ebooks and other online resources is inconsistent from one country to another, a problem made especially clear during the pandemic. Licensing creates even greater hurdles for e-book use in Europe due to the absence of USA-style "fair use" doctrine.
 - iii. Presentation on Ukraine libraries during the war
 - iv. Ukraine-related issues were present throughout the conference and during the remainder of the trip
 - v. Panel discussion on "diamond" open access

- i. Scheltema, "Holland's greatest bookstore"
 - 1. Looked at bookstore to see what was popular in the Netherlands for collection development
 - 2. Books by immigrants in the Netherlands: How do immigrants view their new country and how do they view the country they came from?

 - a. Conflict and violence exhibition that focused on Ukraine
- iii. Visited Erasmus vendor headquarters in Amsterdam

- d. Insufficient time to present Belgian part of trip (Brussels: Royal Library of Belgium, European Commission Library, Jewish Museum of Brussels, Migration Museum; Leuven: KU Leuven Library, Leuven University Press

 - i. Can Title VI money be used for books?
 - 1. Yes; Title VI supports a variety of needs related to designated "less commonly taught languages" on campus including trips and collections.
 - ii. Did bookstores close down during the pandemic in the Netherlands and Belgium?
 - 1. Unsure, but fewer books were published during the pandemic because of a shortage of good paper.
 - iii. How did this trip influence your collection development at UCB?
 - 1. Spoke with many librarians while making many connections that can be developed.
 - 2. Lots of discussion about how various libraries operated during the pandemic.
 - Leiden University Library had excellent programming on local research, which could be something the UCB libraries could adopt.
