1. Announcements and updates (All)
 - a. Membership updates
 - i. New members: Adam Baron (ex officio; Chair) representing MdS and SILS Resources Management; Jackie Gosselar (ex officio) representing LIT; Linda Vida (ex officio) representing IGSL
 - b. [PCC Task Group to Test the Official RDA Toolkit](#) (Adam)
 - i. The new RDA Toolkit will be implemented by PCC no earlier than October 2022.
 - ii. Adam is serving as co-chair of the PCC Task Group to Test the Official RDA Toolkit.
 - iii. The group has just begun meeting and will work to identify a pool of potential evaluators to evaluate the test. A second pool of testers to test cataloging with the new toolkit will be established later.
 - iv. All of the group's documentation will be made available and catalogers are welcome to serve as unofficial testers.
 - v. The group will welcome feedback from testers via the [PCC RDA Communications Committee](#).
 - c. Linked Data Interest Group update (Frank)
 - i. The Linked Data Interest Group met on January 24, 2022.
 - ii. Haiqing Lin gave a presentation and demo of [Sinopia](#), a metadata tool for encoding records in BIBFRAME. Sinopia is still under development and it should be useful in the future.
 - iii. The interest group meeting was recorded; anyone who would like to access the recording should contact Frank Ferko.
2. Review [updated charge](#) (Adam)
 - a. CMC reviewed and approved the updated mission statement and charge.
 - b. Changes reflect new membership and revisions based on the new SILS environment and reporting structures.
3. [Cataloging Code of Ethics](#) (Adam)
 - a. Adam presented the ALA Cataloging Code of Ethics at the December 2021 CMC meeting and several members distributed it to various UCB Library constituencies. However, no group offered any feedback.
 - b. The code does not affect the application of national cataloging standards, or replace national standards; it should just cause the cataloger to think carefully about their application.
 - c. CMC unanimously voted to endorse the code.
 - d. Possible next steps:

- i. Create a small task force to work with existing units/groups to solicit ideas and create concrete examples.
 - ii. Questions to ask and answer: What are we doing now? What would we like to see done in the future? How can we improve?
- 4. SILS updates and questions
 - a. Resource Management: Cataloging and Metadata Operations Subteam (RM-CMOS)
 - i. Adam is the UCB representative to the systemwide RM-CMOS.
 - ii. OCLC is offering a reclamation project that some UCs are interested in, but there are questions about how it would work if not all UCs participated, and how it would affect WorldCat Daily Updates.
 - iii. There are also WorldCat Daily Updates implications for some vendor-supplied records for shelf-ready materials.
