# PRELIMINARY GUIDE TO THE BANCROFT LIBRARY FOREIGN ARCHIVE MICROFILM COLLECTION

The Bancroft Library has long been a center of historical research, largely because of its great collection of original manuscripts. Over the years these collections have been supplemented by microfilm of thousands of manuscripts and other rare materials from archives around the world. Built around the manuscript collection, the Bancroft microfilm collection is today one of the largest in the country, capturing documents from archives in Mexico, Spain, Brazil, France, Great Britain, the Netherlands, Portugal, Germany, and Italy. The microfilm was acquired both through the selection of generally useful and representative materials from various archives and as a by-product of specific research projects. The documents microfilmed are largely related to western North America and the Pacific coast, Mexico, Brazil, parts of Central and South America, and the Pacific islands.

Previous to the advent of microfilm, the Bancroft Library collected transcripts, photostats, and record prints of archival materials from abroad. This collection, developed by Bolton and others, was also built around the Bancroft manuscript collections. These older collections, also extensive, consist mainly materials from archives in Mexico and Spain.

This preliminary guide to the film collection is only a summary, designed to present a general picture of the character and scope of the materials available. Microfilm binders in the reading room give descriptions of the holdings in greater detail. Printed guides and catalogues to specific archives are also referenced when available. For some of the archives an attempt has been made to describe the general contents of the archives themselves as well as the materials microfilmed by the Bancroft Library. For microfilm of some sections of the Archivo General de la Nación more detailed descriptions of the contents are included.

# Microfilm Binder 4 GREAT BRITAIN

As a result of its research program in England, the Bancroft Library has succeeded in acquiring a sizable and extremely useful collection of materials from the archives of Great Britain. The Library continues to receive occasional shipments of film from England, especially from the Public Record Office in London.

## ADMIRALTY LIBRARY

- 1736-1822 (Selections)
- This 7 reel collection of accounts of voyages to the Americas contains descriptions of Central America, Mexico, California, and North West America.

## BRITISH MUSEUM NEWSPAPER LIBRARY, COLINDALE

- 1810-1906 (Selections)
- The Library has received 76 reels of film of rare newspapers from Mexico, the Caribbean area, Central and South America, and western North America, which are listed in the Library's newspaper catalogue.

## COMPANIES REGISTRATION OFFICES, LONDON AND EDINBURGH

- 1856-1920 (Selections)
- These offices had their origin in the 1856 passage of one of the first of the Companies Acts.
   They contain probably the richest collection in Great Britain of materials for American economic history.
- In these offices are housed the official corporate records of every joint stock company (public or private) founded in England, Wales, or Scotland since 1856, as well as records of companies which were in existence in 1856 and continued to operate thereafter. All companies are registered regardless of their location of business. The Bancroft Library has filmed the papers of those organizations operating in Western and Central America and Mexico during the latter half of the nineteenth century and the early twentieth century. The records filmed are miscellaneous and among other issues they include colonization, railroads, and land speculation.
- Records of chartered companies previous to 1856 are kept by a special office at Hayes, Middles, and few records of such companies are found in the Companies Registration Offices unless the company continued to do business after 1856. The Bancroft Library has filmed a few of the papers from Hayes.
- The Library has an alphabetical list of company records filmed, as well as a printed register listing all companies, regardless of location, established between 1856 and 1920.
- The records are especially valuable because of the detailed information which they contain. The law required companies to file the following:

- <sup>o</sup> Memoranda of Association (names of founders, purposes and reasons for association).
- <sup>o</sup> Articles of Incorporation (similar to those in the United States but in greater detail and giving much information as to operational procedure to be followed).
- ° By-Laws.
- <sup>o</sup> Annual financial statements and complete annual lists of stockholders (of each and every type of security issued), showing name of stockholder, residence address, profession, craft, trade or specific employment, stock held, amount paid, annual charges.
- All changes in corportate structure, officers, addresses, by-laws, reduction or increase in capital, new security issues, balance sheets (after 1909, copies of official meeting calls, and court orders.
- OVoluntary windup notices, appointments and reports of closing officials or receivers, and final reports.

## **BRITISH MUSEUM**

- A selection of manuscripts and books from 16<sup>th</sup> to 19<sup>th</sup> century mostly dealing with New Spain, California, and independent Mexico.
- Includes also 1 reel of the Burghley Papers for the years 1584 and 1585. These papers contain information on imports from Spain and its colonies to England.

- 54 reels of Correspondence and State papers relating to England from the Archives of the United province at the Hague.

## BRITISH MUSEUM – PAPELES VARIOS DE INDIAS

- 11 reels of documents written in Spanish relating to geography, trade resources, Jesuit missions, and establishment of Franciscans in Peru and New Spain. There are some references to the Philipines and Portuguese America.

## BRITISH MUSEUM – PORTUGUESE MANUSCRIPTS

- 1750-1777 (Selections)
- These 17 reels include information on the Marquis de Pombal dating from 1750-1777; on the relationship between Spaniards and Portugese in southern Brazil; and on eighteenth-century trade with Brazil.

## BRITISH MUSEUM VENEZUELA PAPERS

- 1530-1824 (Selections)
- 19 reels including disputes over Venezuela and the surrounding regions involving the Spanish, Dutch, English, French and Portuguese.
- Most of the documents deal with the threat of Dutch and English pirates, the organization of Spanish forces, the trade of pearls and tobacco, and the evangelization of South America.

The files are very complete and include correspondence, transmitted letters, documents, clippings, etc. In the Bancroft Library there are lists giving the title, subject, and date span of each volume.

The Library is particularly indebted to Professor A. P. Nasatir of San Diego State College for the materials that he selected and had microfilmed.

# ARCHIVES DU MINISTERE DES AFFAIRES ETRANGERES, PARIS

[The description below is taken largely from the introduction to Waldo G. Leland's Guide to Materials for American History in the Libraries and Archives of Paris, volume II, "Archives of the Ministry of Foreign Affairs."]

Materials for American history abound in the archives of the Ministry of Foreign Affairs. They are scattered throughout a tremendous mass of diplomatic documents covering every phase of French foreign relations from 1500 to the present day. Although this depository is one of the largest of French archival collections, its organization is one of the least complicated. This is due in part to the early adoption by the foreign Office archivists of a policy of classification that was both comprehensive and simplified, and to the consistent adherence to this policy for more than one hundred and fifty years.

The archives are organized in three major series: Correspondance Politique, Memoires et Documents, and Correspondance des Consuls. Each series is in turn subdivided into fonds identified by the names of the states or areas to which the constituent documents refer. The fonds are grouped in alphabetical order, the individual documents within each being arranged chronologically and for the most part bound into consecutively numbered volumes.

The primary series, Correspondance Politque, consists of the correspondence of diplomatic agents abroad with the ministry in France, and of the correspondence of the ministry with foreign agents accredited in France. All types of documents are included in this section—drafts and originals of instructions to and reports from French representatives, as well as drafts of communications to the representatives of other states and originals of the letters of these numerous and varied enclosures that accompanied the principal documents.

The second major division of the archives, Memoires et Documents, contains a wide variety of memorials and accompanying papers prepared by or submitted to the ministry, and referring directly or indirectly to the foreign relations of the state. These documents are classified according to the same system as is the Correspondance Politique: subdivisions are identified by the names of the states, while individual documents within each classification are arranged chronologically in consecutively numbered volumes. One important variation arises from the fact that among the Memoires et Documents is a large series of volumes filed under the designation France, which fonds does not appear in the Correspondance Politique.

The third and last section of the archives is the Correspondance des Consuls which includes instructions to and reports from French consular agents in various parts of the world. As is the case with the Correspondance Politique, the consular correspondence contains a large amount of subsidiary material originally enclosed with the major documents of the series. This section is divided into correspondance politique des consuls, and correspondance commerciale des consuls. The series is classified by names of states, with a sub-classification by names of specific consular jurisdictions within each state. The final arrangement of documents for each jurisdiction is chronological.

- The second carton contains information on the period 1868-1874, mostly consular correspondence from California transmitted by the foreign minister to the ministries of commerce and agriculture, and some information on commerce and industry in San Francisco. These are full commercial and economic reports sent by the French consuls in California for nearly every year from about 1855 to 1874.

# PREFECTURE DE POLICE, ARCHIVES DE LA POLICE JUDICIARIES, PARIS DOCUMENTS RELATIFS A LA LOTERIE DES LINGOTS D'OR

- From the Prefecture de Police in Paris, the Bancroft Library has obtained on film a complete
  record of one of the largest of the French gold rush companies, the Loterie des Lingots
  d'Or, which operated under government auspices. Over fifteen shiploads of emigrant
  workers came to California as a result of the efforts of this company. The records, covering
  the years 1849-1860, contain correspondence, minutes of meetings, lists of company
  personnel and of emigrants, financial accounts, bills, letters of Patrice Dillon consul at San

Francisco, printed publicity for the venture, passenger lists etc. Seven of the ten cartons of miscellaneous papers relating to this company were filmed for the library. Some additional and supplementary material on the Loterie des Lingots d'Or may be found in microfilm obtained from the Archives Nationales, Paris.

#### **MEXICO**

The Bancroft Library's microfilming program in Mexico has been primarily concentrated in the great Archivo General de la Nación. From time to time, it has been possible to acquire film of selected items or of records concerning particular topics from other archives. Professor Woodrow W. Borah and others selected a number of these Mexican materials for filming. In

addition to microfilm, the Library has many record prints and transcripts of documents in Mexican archives. They have been noted below.

The Bancroft library collection includes many items from the Archivo General de la Nación in Mexico City. Undoubtedly the most important archive in Mexico, it was originally planned by the Viceroy Conde de Revillagigedo (1789 to 1794), to remedy the disorder of the records of the viceroyalty. It was not formally organized until the mid-19<sup>th</sup> century. At that time the various ramos, or branches, of the archive were organized.

A useful aid in working with materials from Mexican archives is Herbert E. Bolton's Guide to Materials for the History of the United States in the Principal Archives of Mexico [Bancroft, CD3658.U6.B6, 1977]. Although some rearrangement of the archives has occurred since Dr. Bolton investigated them, most of the information in his guide is still accurate. For a general guide, see the Archivo General de la Nación's Guía General [Bancroft, CD3653 A75 1990].

- 1820s-1850s (Selections)
- The Bancroft Library has 93 reels of manuscripts concerning military reports, appointments of officers, trials, as well as descriptions of commerce and government. These selected documents refer to Mexico in general but there is a strong emphasis on Northern Mexico and Mexican city ports between the 1820s and the 1850s. The main topics are Micheltorena's government in California, the independence of Texas, the Mexican-American War, the occupancy of some Mexican cities by American military forces, the defense of Mexican city ports, the Mexican War of Reform, and some Indian rebellions in Sonora and northern Mexico.
- Another 399 reels from this archive include service records for insurgents from the state of Jalisco, from 1816 to 1943.

Selections include correspondence documenting commerce, military affairs, mining, taxation pensions and communications, international finance, education, railroad, ejidos and correspondence with local governments, courtesies, invitations, and complaints sent and received by the office of the personal secretary. - 1524-1849 (Selections)
- This very important section of the Archivo General contains 450 legajos, almost all the records of the Cortés family and their estate, the vast Marquesado del Valle. The selections from this archive give an account of the estate and its administration from 1524 to 1835. It also includes some documents on the estate of the Duque de Terranova y Montelon. The library has received more than 25,000 exposures (about 50,000 pages) from this collection and has record prints of a number of 16<sup>th</sup> century items.
- Bancroft Library also has a selection of 18 legajos that form part of a larger collection entitled "Papeles sueltos". This selection contains correspondence to or from Lucas Alaman between 1820 and 1849.

Summary: This archive includes the records of the Cortez family encomienda and estate during the administration of Hernan Cortez, his son Martin, and grandson Pedro Cortez, while holding the title of Marque del Valle and Capitan general de Nueva España. The Cortez family had civil and criminal jurisdiction of over 23 thousand indigenous subjects and the

collection of tribute, administration of land, criminal and other legal proceedings, military activities, and supervision of local indigenous authority. The collection also documents the administration of the Hospital de Jesus, which was part of the Cortez family estate. Also included in this archive are documents from the estate of Duque de Terra Nova y Montelon, and selections from a collection entitled "Papeles sueltos," which includes correspondence to and from Lucas Alaman between 1820 and 1849. - An important section in this collection is entitled "Documentos para la historia de México." It is a set of twenty volumes (ca. 1720 to 1840), most of which came originally from the archives of the Franciscan Colegio de San Fernando, which directed Franciscan missionary activity in Northern Mexico. These documents relate primarily to the Californias and include such important items as the correspondence of Lasuén, Serra, Crespi and Palou, as well as other general correspondence.
- Bancroft has also a large collection of microfilms from the section entitled "Temporalidades". It includes references to the Real Caja of Chihuahua; letters from Jesuits in Northern New Spain from 1707 to 1767; memorials; statistics from northern missions; various documents concerning the supply of missions in Sonora, Sinaloa, and California between 1585 and the 1770s, information on the exploration in Alta California in the 18<sup>th</sup> and 19<sup>th</sup> century, and some documents on aduanas and commerce between 1801 and 1842.

The Bancroft also has on film miscellaneous manuscripts, chiefly involving Viceregal correspondence, tribute in the 16th and 17th centuries, duties and the tobacco monopoly (1770 to 1803), and the navy in the 18th century. - 1517-1819 (Selections)
- This ramo consists of printed proclamations from the king of Spain to the colonial authorities dealing with a variety of issues in the government of New Spain. Bancroft

Library has a collection of 32 reels of this ramo which includes proclamations concerning manufacturing regulations and the silk industry (1767 to 1800), as well as some bandos from the 16<sup>th</sup> and early 18<sup>th</sup> centuries.

**Summary:** Printed proclamations from both colonial authorities and the King of Spain related to the administration of New Spain, including ecclesiastic, economic, and military affairs, criminal and civil justice, manufacturing, and the silk industry. The collection includes some bandos from the 16<sup>th</sup> and early 18<sup>th</sup> centuries, but the bulk of the documentation falls between 1761 and 1800. Originals held at the AGN in Mexico City. Bancroft has all 32 volumes on microfilm. See finding aid for reel correspondence.

## **CALIFORNIAS**

- 1767-1822 (Complete)
- The Bancroft Library has filmed all 82 volumes of this ramo. They consist mainly of correspondence with the local officials of the Californias. The bulk of the material is for the second half of the 18<sup>th</sup> century, although there are some documents concerning the earlier exploration of the area.
- There are several volumes relating to the administration of the Pious Fund after 1822, and to the relations with Philippines.

**Summary:** Primarily correspondence with local officials of the Californias. The bulk of the documentation is from 1767-1822, but there are a few documents concerning early Russian and British exploration of the area, as well as some documents from the Real Tribunal de Cuentos, which administered the Pious Fund after 1822. Originals held at the AGN in Mexico City. Bancroft has all 82 volumes on microfilm. See finding aid for reel correspondence.

**Notes:** In Spanish. There is a discrepancy between the Bancroft records and the description of the original collection in the *Guia General* of the AGN. This selection deals with the activities of Franciscan missionaries in northern New Spain between 1640s and 1801. It includes references to the College of San Fernando, the province of the Holy Gospel of Mexico, and to their missions in New Mexico, Texas, California, Sierra Gorda, and Sonora.
- These reels also include some documents from the section entitled Colección Gómez de Orozco, which includes some Reales cédulas and bandos dating from the late 18<sup>th</sup> century.

- Through the efforts of Professor Engel Sluiter the Bancrfot Library acquired nearly 100,000 exposures of film from the General State Archives at The Hague. Most of this material concerns Dutch maritime activities in the Western Hemisphere during the seventeenth and

eighteenth centuries. Many of the records are from the files of the Dutch West India Company.

#### **PORTUGAL**

In 1949 Dr. Gwendolin B. Cobb went as the Bancroft Library's representative to Portugal, where she spent twenty months in research and microfilming. This successful project resulted in the acquisition by the Library of over 10,000 exposures of film, most of it general documentation relating to Brazil, and to some extent to other Portuguese colonies, and heavily concentrated between the late sixteenth and the early eighteenth centuries.

The majority of the filming was done in the Arquivo Historico Colonial in Lisbon, although a limited number of material was obtained from other archives. For additional description of the microfilming project in Portugal and materials photographed.

## ARQUIVO HISTORICO COLONIAL, LISBON

- The Library has film of 95 boxes (caixaz) of unbound documents and 115 boxes of bound volumes, as well as of a few shorter selections. This archive contains materials concerning the Portuguese colonies and dating from the 16<sup>th</sup> century. The sections filmed by the Bancroft Library deal with colonial Brazil, and consist mainly of the papers of the Conselho Ultramarino, relating to almost every phase of colonial interest and administration. This collection, formerly housed in the Biblioteca Nacional, constitutes a registrar of the official and private documents either received by or emanating from the Conselho Ultramarino (1584-1824). ## ARQUIVO NACIONAL TORRE DO TOMBO

This is the national archive of Portugal and functions as a depository of current records as well as of antiquities. It is rich in sixteenth-century materials for the study of Portugal in America, but as there are no catalogues and few indexes of the contents of the archive, time limitations allowed the filming of only a few documents.

- Corpo Cronologico, 1521-1551. Selected documents including references to commerce, ships, letters to the King, and some royal orders.
- Cartas Missivas, 16<sup>th</sup> century. This selection deals with commerce and pirates of the coast of Pernambuco. A few letters were filmed from this section consisting of royal correspondence.
- Livros de Leis, 16<sup>th</sup> century. References to legal dispositions concerning Jews and Foreigners. Several Laws from Books I and II of this collection were microfilmed.

These selections in include chronicles, reports of royal officers, memorias, and several other documents written by Spanish conquerors, colonial authorities, and clergymen. The Archivo General de Indias is the great repository for the records of Spain's colonial empire. The Bancroft Library has been fortunate in obtaining microfilm and transcripts of many important documents from this vast and rich storehouse of source material.

In about 1930, the Archivo General de Indias changed the system by which it numbered its many legajos. Nearly all the Bancroft Library's microfilm bears both the old and new destinations. Many of the transcripts are stilled labeled only by the old system, but there is, in the Library, a partial list of equivalent destinations.

The Library has received microfilm of almost all the manuscripts listed in Charles E. Chapman's Catalogue of Materials in the Archivo General de Indias for the History of the Pacific Coast and the American Southwest, as well as a number of related items from the legajos investigated by Chapman, but not entered in his guide. These materials document the period from 1597 to 1821, although the bulk of the collection is for the eighteenth century. In addition, the Library has reproductions of other collections and selected material as noted below.

### THE AUDIENCIAS

• Most of the material filmed for the Bancroft has come from the Audiencia sections of the archive. Although these miscellaneous papers are classified geographically by Audiencia, they also refer to matters outside the Audiencia courts. The crown, the Council of the Indies, the Casa de Contratacion and other agencies of government in Spain and the colonies, private individuals, and secular and ecclesiastical officials of every rank are all represented in these documents.

The Bancroft Library has materials on film relating to the activities of General Pedro Menendez Marquez (1555-1599), to Bartolome de las Casas (1520), and to seizures of various Spanish vessels by the Dutch (1593-1719).

- The Library has 8 reels of film of the correspondence and official documents of Arturo O'Neill, the governor of Pensacola (1785-1787, 1791-1793); letters written by the governor of Louisiana (1766-1771), and correspondence with him (1792); and correspondence and documents relating to Mississippi (1794-1798).
- The Bancroft Library has a significant collection of transcripts relating to Louisiana (1704-1833), consisting largely of materials from Papeles de Cuba. The large group of transcripts relating to Louisiana and the Floridas (1704-1833) mentioned above under "Papeles de Cuba" includes documents from the sections of Audiencias de Mexico, Audiencia de Santo Domingo, and Indiferente General.

A number of these manuscripts listed in the Chapman guide come from this section and the Library has microfilm of almost all of these, in addition to a few miscellaneous selections.

The section is rich in information for the sixteenth century; there is little or nothing for the eighteenth. Included are papal bulls and briefs, accounts of discoveries and settlements, papers relating to the government of the Indies, records of mining, etc.
- Bancroft Library has microfilm of a collection of documents concerning the discovery and exploration of New Mexico (1568-1613), selected materials on Bartolome de las Casas (1516-1561), and a few miscellaneous manuscripts (1554-1590).

- Sluiter collection includes 26 reels of treasury accounts for Mexico, Peru and New Granada for the 16<sup>th</sup> to 18<sup>th</sup> centuries as well as documents on the trial of Hawkins' men for Lutherism.

From the section entitled Guerra Moderna, the Bancroft Library has film of a number of manuscripts relating to the Provincias Internas (1783-1805), to the Californias (1788-1799), and to Colotlan and Nayarit (1790-1799).
